This will help someone who may want to do forms at their level, but spar at a higher level. This will also help people who might be a black belt in Taekwondo, but a beginning grappler.

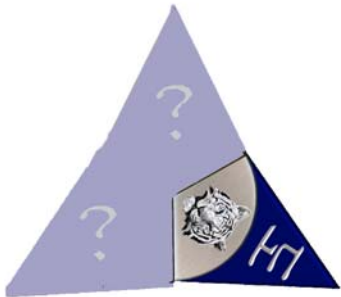

## Prizes



The winners of each division will receive medals. All 5 year olds and under will receive at least the bronze medal. The winners of each division will also receive 3 points (Gold Medal), 2 Points (Silver Medal) or 1 point (Bronze Medal). You can receive a maximum of 3 points per event.

The point totals will be used to determine the individual grand champions (Jr Color belt, Jr Black Belt, Sr Color Belt, Sr. Black Belt)



The medals represent the first piece in a puzzle that can be completed only by winning medals in the Twin Dragons Tournament (Jan 2013) and Lone Wolf Classic (Fall 2013)



Winners in the **black belt** (or advanced) divisions will win an Adidas Adichamp III uniform (for Olympic Sparring) or a Century UFC Rashguard (for grappling). Note, divisions will be set based on entrants to ensure good competition for everyone. Note, winners will select their size and color at the tournament and receive the prize shortly afterwards.



## Grand Champion

There will be four grand champion swords (U15 Color Belt, U15 Black Belt, 16+ Color Belt, 16+ Black Belt) awarded to the individuals who earn the most points.

## Directions and Location

The tournament will be held in the PE gym of Metro State College of Denver. This is a spacious facility with bleachers, overhead viewing/taping areas, an ample-sized holding/warmup area, and good ventilation. See the map for more details.



## Rules and Mandatory Equipment

**Uniform:** Recognized martial arts uniform. Costumes allowed for demo team.

**Safety Equipment:** - WTF/USAT Approved!

Shin & Instep, Forearm, Head Gear, Chest Protector, Groin Cup (Males, worn on inside of pants). A mouthpiece is mandatory! For grappling, cup and mouthpiece are required.

Traditional Forms and Olympic Style Sparring will be judged by current USAT rules. Breaking competitors will have three chances per board and must provide their own breaking materials. Breaking, Creative Forms, Group Forms, and Weapons Forms will be judged for style, skill, balance and overall presentation. Creative, Group, and Weapons forms may have music and have a time limit of 3 minutes. Blaster Pad Sparring – Knock your opponent down or out of the ring! Best 2 out of 3 wins. No skill divisions. **For demo team, we will offer both a long and short demo. \*Compete if both demos for the same price.**
